 - II. <u>Nominal Rolls (One Copy)</u>: Prepare the nominal rolls batch wise and Hall Ticket number wise and submit the copy with EAF forms. The examination application forms submitted by the Principal/Directors should tally with the nominal rolls. Any name without application cannot be considered.
- 6. Instruct the students to enclose the Xerox copies of Memorandum of marks of earlier Examination.
- 7. Application forms with all the above requirements should reach the Examination Branch, O.U on or before <u>22nd January</u>, <u>2018</u>. If EAF is prepared after <u>22-01-2018</u> a late will be imposed.
